- A KSA representative will sign the Artist Receipt for you to retain for your records.

Artists: you are invited to participate in KSA's annual holiday show: **"Small Work/BIG SHOW 2021"**. It is an Open, Cash & Carry Show; not a juried show. Buyers may purchase and take artwork immediately

Entries Due: Entries must be hand delivered to the KSA Gallery **Saturday, Nov 13, 2021 from 11am to 5pm.**

No late entries accepted.

Eligibility: All KSA members are eligible to participate. Kaua'i resident artists 18 years or older may join KSA on entry day. KSA membership dues for individuals are \$25 per calendar year.

Entries: KSA will accept up to 4 pieces from each artist subject to eligibility and exhibit criteria: KSA may contact you to bring in more work if your work sells at no extra entry fee.

Fees: \$8.00 per piece; Fees are non-refundable.

Criteria: All 2-D and 3-D media are eligible subject to the following criteria:

1. **Maximum size allowed is 20"x 20"x20", including frame, stand or other display method.** No Exceptions to size limit. Entries will be measured on entry day.
2. **Art must be original** and independently created by artist or collaboration of artists, **within the last 3 years.** No student work created in a classroom or under an instructor's direction will be accepted.
3. **Copies or reproductions of works** originally created in a different medium are not allowed, unless reproduction is an integral part of a new artistic or conceptual statement.
4. **Work previously shown in a KSA show is NOT eligible.**
5. All work must be complete, dry and ready for installation. Avoid dirty mats or glass, unframed canvas with staples showing, poorly constructed framing or temporary methods of display such as "shrink-wrap", etc. **All wall-hung pieces must have hanging wire securely attached.**
6. The Kukui Grove Center Management prohibits the display of the naked human form or any work that they consider obscene. KSA reserves the right to not accept work considered inappropriate, incomplete or unsafe.

Sales & Commission: Artists are encouraged to offer their work for sale. While not a requirement, one focus of this show is to offer artists and the buying public sales opportunities. 25% of sale price is to be donated to KSA.

Publicity: Artists agree that KSA may use images of works from the show in publicity and show promotion, such as newspapers, newsletters and the KSA website. Full copyright acknowledgement is given when possible.

Show Sitting or Payment for Show Sitting: All participating artists are requested to show sit 2 sessions of 3-4 hours each. A Show Sit fee of \$60 is requested in lieu of show sitting--to hire a qualified person to show sit for you.

Pickup of Work: Artists are responsible for pickup of artwork at end of the show. KSA is not responsible for work left after pickup deadlines. Pick-up day: **Saturday Jan. 8, 2022 from Noon to 4 pm.**

Payments to Artists: Will be sent within 2 weeks **after the end of the Show.**
