Artwork Requirements

- Must be created from at least 50% man-made marine debris.

 Driftwood and natural beach debris are not included in this 50% requirement.
- Photographs or Paintings must include images of at least 50% man-made marine debris.
- All Marine Debris (nets, rope, plastic) **MUST be cleaned properly.** This means soaked in a vinegar/water mixture for at least one day.
- Marine Debris artwork that has not been cleaned properly will not be accepted. Please contact artinkauai@gmail.com for more information on cleaning.
- As Usual: Previous work shown in a KSA Show is not acceptable!

2024 "Washed Up Show" exhibit criteria & artist's receipt

Entry Day: Sat. June 1, 11am -5 pm Exhibition: June 7 - 28, 2024

Reception: Sat, June 8, 2024 (World Ocean's Day).

Artists: you are invited to participate in our 6th Annual Marine Debris Show: "Washed Up"

This is an Exhibition. If your work sells, you must leave it in the show until the end. Two exceptions only: Air Plants and "School of Fish" Series.

Entries: Entries must be hand delivered to the KSA Gallery Sat June 1, from 11 am to 5 pm. No late entries accepted.

<u>Eligibility</u>: All KSA members are eligible to participate. Kauai resident artists 18 years or older may join KSA on entry day. KSA membership dues for individuals are \$35 per calendar year.

Entries: KSA accepts up to 6 pieces subject to eligibility & exhibit criteria.

Fees: \$5.00 per entry plus current KSA membership.

<u>Criteria:</u> All 2-D and 3-D media are eligible subject to the following criteria:

- 1. 50% of art must be created from MAN MADE Marine Debris; not natural debris, i.e. Drift Wood or Sea Shells. Photographs or paintings must include 50% focus on marine debris. ALL Marine Debris must be cleaned properly by being soaked for at least one day in a vinegar/water mixture.
- 2. **Photographic art** subject matter must include focus on marine debris.
- 3. Art must be original and independently created by artist, within the last 3 years.
- 4. Work previously shown in a KSA show is NOT eligible.

- 5. <u>All work must be complete, dry and ready for installation</u>. No dirty mats or glass, unframed canvas with staples showing, poorly constructed framing or temporary methods of display such as "shrink-wrap", etc. All wall pieces must have a hanging wire securely attached.
- 6. **Show Sitting:** All participating artists are required to show sit two 3-hour show-sitting sessions or pay a show-sitting fee of \$60.so KSA can hire a show sitter for you.
- 7. <u>Sales and Commission</u>: KSA receives a 25% donation on all sales made during the show. Selling your work is not a requirement, but KSA encourages all artists to offer their work for sale.
- 8. **Publicity:** Artists agree that KSA may use photographs of artwork in publicity, such as newspapers, KSA website, enewsletters, etc. Artists will be given full copyright acknowledgement when possible.
- 9. <u>Kukui Grove Management prohibits</u> the display of the unclothed human form or work that they consider obscene. KSA reserves the right to not accept work considered inappropriate, incomplete or unsafe.
- 10. <u>Pickup of Work:</u> Artists are responsible for pickup of artwork at end of the show. KSA is not responsible for work left after pickup deadlines. Pick-up day: **Sat., June 29, 2024** from **Noon to 4 pm**.
